# Greater Area Ann Arbor Intergroup - Bylaws Amendment Proposals May 16, 2020

Intergroup Representatives will present these Proposed Bylaws Amendments to the group they represent, obtaining a group conscience vote "for" or "against" each proposal. At the June 20, 2020 Intergroup Meeting the Intergroup Representative will vote their group's conscience vote.

## Current and Approved GAAAI February 20, 2005 Bylaws:

### #1 - Article III – Members – Section 4: Absences of Intergroup Representatives

Reads: The IG secretary shall notify Representative Groups of their IR's absence

**Proposal:** Delete Section 4 of Article III

Rationale: It is the responsibility of the Represented Group to hold accountable the IR's

attendance at IG meetings as outlined in <u>Article III – Section 3</u>:

### **Section 3 - Intergroup Representatives**

- A.) Intergroup Representatives shall be selected by the group conscience they represent. Each (IR) shall be selected by any method deemed appropriate by their group. These (IR)s shall serve for a period designated by their group, always subject to recall by the group they represent. Each group shall be free to designate an alternate group representative when the necessity arises.
- B.) Intergroup Representatives should be selected for willingness to serve, commitment to the Twelve Steps and Twelve Traditions of OA, length of time in Program and length of service.
- C.) The primary responsibility of the IR, or alternate, is to represent their group at all meetings of the Intergroup, to act as a liaison between this Intergroup and their group, to see that all communications pertaining to Intergroup are made available and, where requested, read aloud to the group.

# #2 - Article III - Members - Section 5: Membership voice and no vote may be:

Reads: A.) Any Employee

B.) Any member of the Fellowship who is not a duly elected representative or alternate

**Proposal:** Delete Section 5, A & B of Article III

**Rationale:** A.) IG does not have paid employees. IG pays for the technical services managing the IG website; however, that individual does not attend IG meetings, nor has a voice in matters concerning IG business.

- B.) Members who are visitors to an IG meeting is addressed in **Article III Section 1 B. 1.):** B.) Individual Meetings' IG Representsatives:

  1(IR) per Meeting or Meeting Alternate.
  - (1.) Non-voting visitors are welcome at Intergroup meetings and have a voice in discussions.
